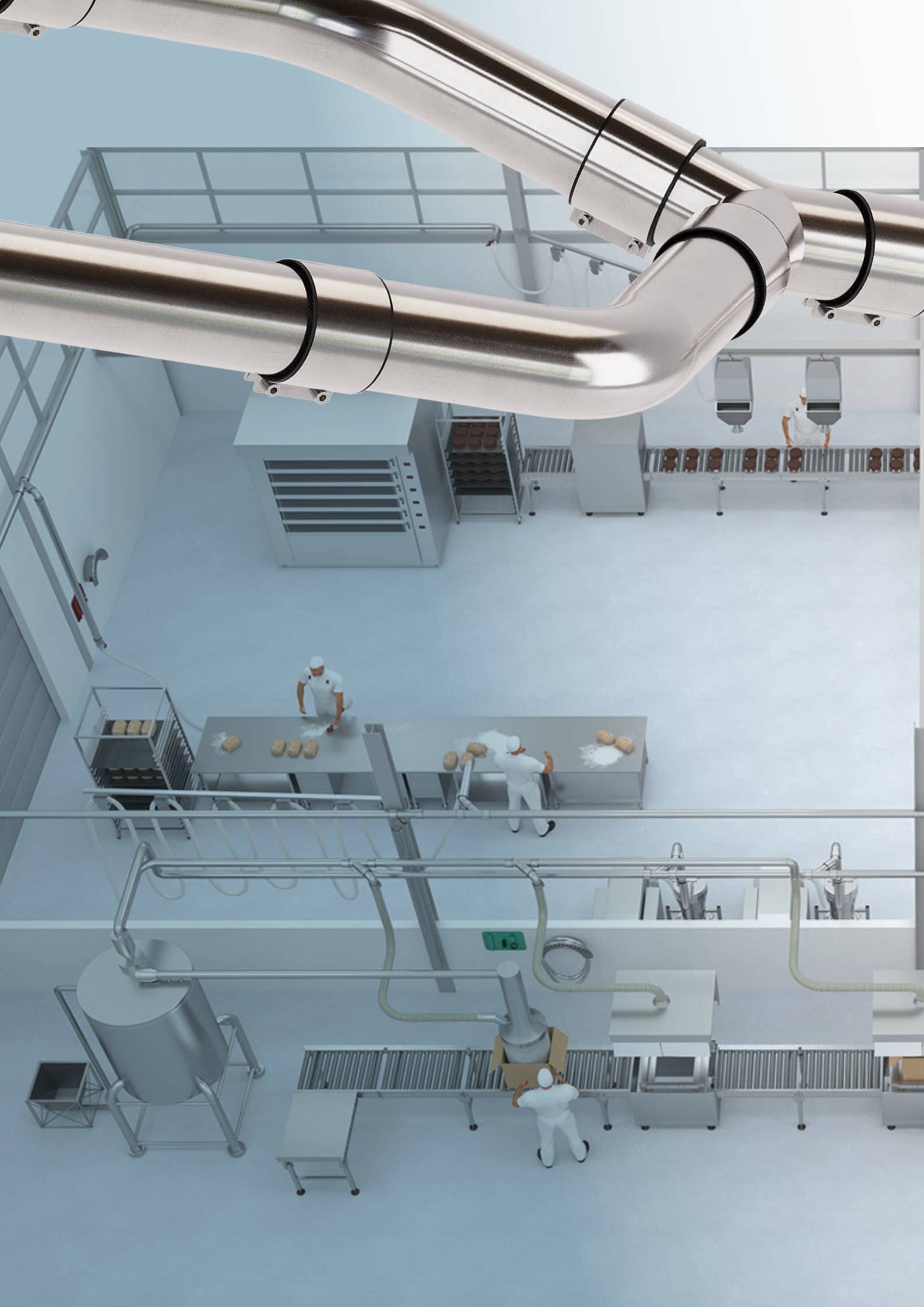

Suction Brushes



ATEX The term "ATEX" derives from the French "ATmosphères EXplosibles" and refers to atmospheres that are potentially explosive. **EU Directive 1999/92/EC** covers the health and safety of workers in such environments. All equipment marketed in the EU for use in explosive atmospheres with "inherent ignition sources" must fulfil the requirements of Directive **2014/34/EU**.



Autoclavable Suction brushes should be cleaned, as appropriate to their intended use, before use and after use, using the appropriate decontamination chemicals, concentrations, times and temperatures. The suction brushes can be autoclaved up to 121°C.



Colour Coded Colour Coded Suction brushes minimise the risk of cross-contamination. It enables the operator to immediately see if the correct tool is in use for a specific production area or work process. The suction brush holders are available in 5 different colours which may be combined with two different colours of filaments. The filaments are easily exchangeable.



ESD To avoid the triggering of any source of ignition, and making vacuum cleaning operations safe, our brushes have been tested and received approval by RISE (Research Institutes of Sweden) for ESD protective products according to **IEC 61340**.



Detectable The plastic parts of the suction brushes are detectable by conventional metal detection systems used in food manufacturing. Choose the colour (black or white) of the brush filaments to facilitate detection by visual appearance.



Food Safety* and FDA* The vacuum brushes have been tested by Eurofins. The suction brushes comply with the requirements in EU regulation No **10/2011/EC** for plastic material and articles intended to come into contact with food. The product materials meet the requirements of **EU 1935/2004** and **21 CFR 177.1520 FDA regulations, GRAS**.



*Food Safety. For metal and rubber, there are no EU directives. National regulations applies.
